Accounts will be charged for renewal within 24-hours prior to the end of the current period, at the cost of the chosen package. Subscriptions may be managed by the user, and auto-renewal may be turned off by going to the user's Account Settings after purchase in the Apple App Store or Google Play Store. No cancellation of the current subscription is allowed during the active subscription period.

Payments - Cancellations:

You may cancel your subscription at any time via the subscription settings in your Apple App Store or Google Play Store account. To ensure that you are not charged for a subscription following the free trial period, you must cancel at least 24 hours before the end of the subscription period. If you cancel, your subscription will remain active until the end of the current paid period and will not be renewed after that.
